# 5. Neighbourhood Plan

Prior to this meeting of the Parish Council there was an Annual Parish Meeting on the single subject of the Neighbourhood Plan (see appendix A) with 60 parishioners present, starting at 7:00pm and finishing at 8:15pm.

Cllr Mary Harkness (Chair) introduced this item and prior to discussion asked to amend item 5.c. to read as follows:-

It is **proposed** that the Council pause the Neighbourhood Plan and the Neighbourhood Plan Development Group and review this in October 2021 with a view to resuming the Plan with additional recruits.

There was a lengthy discussion on the value of a Neighbourhood Plan involving all councillors.

It was agreed (5 votes for) that this amendment should be put to the Council and replace 5.c.

- a. It was **proposed** that the parish Council continue with the Neighbourhood Development Plan. At a vote this received 2 votes in favour
- b. It was proposed that the NPSG concludes the Issues and Options community consultation, including in that consultation an opportunity for the community to feedback on whether they wish the Neighbourhood Plan process to continue or not.
   At a vote this received 2 votes in favour
- It is **proposed** the parish Council pause the Neighbourhood Development Plan and the NDP Group. This proposal was replace by: It was **proposed** that the Council pause the Neighbourhood Plan and the Neighbourhood Plan

Development Group and review this in October 2021 with a view to resuming the Plan with additional recruits.

At a vote this received 5 votes in favour

The result of the voting was that the amended proposal in item 5.c. was carried with 5 votes in favour.

The Council **RESOLVED** to accept the result of the vote and will pause the Neighbourhood Plan and the Neighbourhood Plan Development Group and review this in October 2021 with a view to resuming the Plan with additional recruits.

# 6. Planning

## a. **7/2021/5319**

Location: Thornrigg, Lyth, Kendal LA8 8F

Proposal: Proposed extension, loft conversion and refurbishment of existing bungalow.

Reply by: 13 August

It was proposed that the Council has no objection to this planning application

The Council **RESOLVED** to accept the proposal

# b. **7/2021/5565**

Location: Land south of St Mary's Green, Crosthwaite LA8 8HU Proposal: two dwellings and footpath – outline application

Reply by: 19 August

There was some discussion on this application with some matters raised being shown following the proposal.

It was **proposed** that the Council objects to this planning application on the grounds that it will destroy the distinctive nature of Crosthwaite.

It is a green field site in open countryside, there are distinctive gateway views across the field towards Whitbarrow from the Millennium Cross and bench, the field is a separation of Crosthwaite Village and Church Town, the infrastructure is inadequate, the houses do not meet the housing needs of the Parish.

Vote – 7 in favour of the proposal

The Council RESOLVED to accept the proposal and asked the Clerk to write to LDNPA

## c. **7/2021/5590**

Location: Mireside Farm, Crosthwaite, LA8 8BT

Proposal: Alteration and extension to farmhouse, conversion of traditional barns into 2 dwellinghouses with local needs/holiday letting dual occupancy, erection of garaging in replacement of modern agricultural buildings and associated works.

Reply by; 30 August 2021

There was some discussion on this planning application with matters raised being shown under the proposal.

It was proposed that the Council objects to this planning application

This is a totally inappropriate application in open countryside with 13 parking spaces. Housing Needs survey shows that the Parish has no need for holiday accommodation. It is not sustainable. It is not farm diversification. The Scale is excessive.

Vote – 7 in favour of the proposal

The Council **RESOLVED** to accept the proposal and the Clerk was asked to write to LDNPA.

# **Annual Parish Meeting**

On 10 August 2021 between 7:00pm and 8:15pm the Parish Council held an Annual Parish Meeting on the single subject of the Neighbourhood Plan.

The floor was then open for discussion when between 17 and 20 people participated. On occasions Mary Harkness and Simon Johnson (Chair of the Neigbourhood Plan Group) answered questions rectifying misinformation wherever possible.
